We are writing to update you on the operations and activity on-site for the COLPAI Project.

As you will be aware, ISG is on-site undertaking construction works to deliver 66 new social homes and a new primary school.

As a local authority, we are committed to smart, safe and motivated working. During these difficult times, we must ensure that we operate 'Business Continuity.' This means having a robust plan in place in order to keep moving forward, contribute to the economy, keep our workforce mobilised and ensure we are in the best possible position to deliver for the local community.

Our priority is to complete the new primary school, ensuring the City of London Primary Academy Islington children and staff can move out of their temporary accommodation and into new state-of-the-art facilities. We are progressing well on-site, with the reinforced concrete superstructure going up. As advised by the Government, vital housebuilding must also continue. We are committed to providing social homes for local people on Islington Council and City of London Corporation's waiting lists.
