PROJECT UPDATE

We are writing to give you an update on works for the COLPAI project site. Demolition works are progressing well and are due to be completed shortly.

Enabling works will be taking place on-site to prepare for construction to begin, this will include pile probing. This is where we check the proposed pile locations for obstructions before piling commences.

The hoarding has now been extended around the site, with the installation of the site cabin/welfare expected to be completed by May 2019.

As part of the works, concrete will be crushed on-site for reuse during the subsequent construction phase. There are many benefits of recycling concrete in this way, including the reduction of vehicle trips to the site for the removal and delivery of material. Less waste will be transported to landfill, which means the development's impact on the environment will be reduced. We estimate that 2.000m3 of concrete and brick will be crushed and reused on-site.
